





7. test equipment

7.1 Dimension Measuring Instrument

The dimension measurement shall be implemented by instruments with equal or more precision scale of 0.1mm.

7.2 Voltmeter

Standard class specified in the national standard or more sensitive class having inner impedance not less than 10 $K\Omega/V$.

7.3 Ammeter

Standard class specified in the national standard or more sensitive class. Total external resistance including ammeter and wire is less than 0.01Ω .

7.4 Impedance Meter

Impedance shall be measured by a sinusoidal alternating current method (AC 1kHz LCR meter).

8. Standard Test Condition

Test should be conducted with new batteries within one month after shipment from our factory and the cells shall not be cycled more than five times before the test. Unless otherwise defined, test and measurement shall be done under temperature of 23±2°C and relative humidity of less 75%.,air 86Kpa~106Kpa.

Unless otherwise defined, 30min, rest period after charge, 30min, rest period after discharge.

9. Storage and Others

9.1 Long Time Storage

If the battery is stored for a long time (don't used, exceed three months), the cell should be stored in drying and cooling place. The cell's storage voltage should be 51V-53V and the cell is to be stored in a condition that the temperature of 23±2°C and the humidity 0f 45%- 75%. Long-term use of unused batteries to recharge every 3 months. Ensure that the battery voltage is within the above range.

9.2 Others

Any matters that this specification does not cover should be conferred between the customer and GSL ENERGY.

Note (3):

GSL ENERGY will inform, in a written form, the customer of improvement(s) regarding proper use and handling of the cell, if it is deemed necessary.

Danger!

- Do not immerse the battery in water or allow it to get wet.
- Do not use or store the battery near sources of heat such as a fire or heater.
- Do not use any chargers other than those recommended by GSL ENERGY.
- Do not reverse the positive(+) and negative(-) terminals.
- Do not connect the battery directly to wall outlets or car cigarette-lighter sockets.
- Do not put the battery into a fire or apply direct heat to it.
- Do not short-circuit the battery by connecting wires or other metal objects to the positive(+) and negative(-) terminals.
- Do not pierce the battery casing with a nail or other sharp object, break it open with a hammer, or step on it.
